Terms and Restrictions

- (1) Thousands of new Domain names are being selected each day. NETS cannot guarantee that your first choice will be available. The sooner you apply, the better chance of getting your desired domain.
- (2) If you are requesting a new Domain name, NETS will act only as your agent to reserve your domain name. The name will be registered under your company, and you are free to move your domain to any other Internet service provider at any time you choose. You cannot register a domain that is trademarked by someone else (i.e. coca-cola.com).
- (3) NETS will enter your domain and provide DNS (domain name services) on our equipment while you maintain NETS Internet Web Site Hosting service. If you decide to cancel your service, you must register with another ISP to insure that your domain name will not get re-assigned to another company due to lack of use. Client is responsible for all registration fees. Client may choose any authorized registrar to maintain their domain name.
- (4) Payment by check must be in advance with application. We do not accept credit cards. If we cannot register a suitable domain name, your payment will be refunded.
- (5) Neither the client nor NETS will be liable to the other party for any indirect, special, incidental, or consequential losses or damages, including without limitation, loss of revenue, loss of customers, clients, or members, loss of goodwill, or loss of profits arising in any manner from this agreement and the performance or non-performance of obligations hereunder.
- (6) Client agrees not to promote or offer any services or activities on the Internet which, by their promotion, sale, or nature would violate any statue, regulation, or order, either enacted by the legislature or Federal, state, or local courts of the United States or its territories, or by any other jurisdiction which has access to the Internet. Any violation of this provision may result in termination of service immediately upon NETS confirmation of such violation. Client will be responsible for any and all penalties and/or damages for violation of any of the aforementioned statue, regulation, or order and shall hold NETS harmless against any and all claims as a result of a violation of this provision.
- (7) The Client shall protect, indemnify, save, and hold NETS harmless against any and all claims including punitive damages, costs, and liabilities of any kind, including reasonable attorney's fees, by reason of this agreement.
- (8) The governing authorities for Internet names requires that domain names be paid for at the time of application. The current DirectNic.com charge is \$15/year with a minimum of one year required in advance for all new registrations. If you are requesting a new domain name, please provide your credit card information on the application for the Domain Name Charge.
- (9) Either party may cancel this agreement with 90 days written notice after the initial service commitment (One (1) year for Small Business Internet Presence and three (3) months for all other packages).
- (10) This Agreement shall be construed and enforced in accordance with the laws of the State of New Jersey. In the event any legal action is taken by either party to enforce any of the terms and conditions of this Agreement, it shall be venued in Sussex County, New Jersey, and it is agreed that the prevailing party shall be entitled to recover from the other party all court costs, reasonable attorney's and paralegal's fees and expenses incurred by the prevailing party in connection with such proceedings, including any associated appellate proceedings.
